<p>Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.</p>	<p>Para 1.20</p> <p>LOUTH CHURCHES' FOR REFUGEES - VICE CHAIRS REPORT 2019/2020</p> <p>During 2019/2020 we have held fast to our core objectives – namely, to Pray, to Act, and to Give. Regular prayer both for the well-being of those displaced by war, conflict and persecution, as well as for the success of our work, has been a feature of all our meetings. We remain a 'faith based' organisation although we welcome members from all parts of our local community. In terms of 'Acting', our organisation finally achieved one of the charity's goals; we received a Syrian family into our community in Louth.</p> <p>Most of 2019 was taken up with the preparations to get the family to Louth. Meetings were held with the Home office, ELDC and LCC. One of the biggest issues we had was to find a house that would be rented to the family for a minimum of two years at an affordable rent. The East Lincolnshire Methodist Circuit offered a very good 4 bedroom house in a pleasant area of Louth.</p> <p>Once the house was found then time was spent making it ready. Donations of furniture and contents were quite overwhelming and we managed to fully furnish the house, only having to dip into our reserves for a washing machine, bedding, and a few odds and ends. The response from people in the local area has been heart warming and we could not have achieved what we have without the kind donations of goods and cash.</p> <p>The family arrived at the end of January, leaving them with very little time to settle in before Corona virus hit the U.K. Schools were found for the children and doctors for the family. Bank accounts were opened and interviews took place with the DWP. One of our biggest concerns was finding interpreters. A Syrian man from Grimsby came forward to offer help before the family arrived. This still left us needing a female interpreter. A couple of days before the family arrived, a lady who spoke Arabic, said she would come to the airport with us. Both of these people have been invaluable and we owe them a great deal of thanks for the work they have done.</p> <p>I think the whole country has been on hold since Covid 19, and the lockdown has made life difficult for our family and for the people supporting them. LCfR have had to rethink, like everyone else, how to support the family yet keep social distance. Zoom has been a very good tool; the education of the children and the ESOL help for all the family has been done by a dedicated team using Zoom. More immediate needs have been dealt with by visits to the house and conversations on the doorstep. As we come out of lockdown some of the group are starting to do house visits and I feel that the family are settling into life in Louth. We all have a</p>

		<p>long journey ahead of us but I'm sure with God's help we will succeed in helping this family become part of the community.</p> <p>LCfR still have a lot of work to do. The refugee situation is not getting better therefore LCfR ask you to continue to 'Pray. Act and Give', so if you can help in any way in the next year please join us.</p>
