Minutes of the second Annual General Meeting of Louth Churches for Refugees

The meeting was chaired by Mr Derek Gibson. 25 members of the charity were present.

Before the formal business of the meeting took place, a presentation was made to John Troughton who was stepping down as a trustee. He was thanked for his hugely influential contribution to the work of Louth Churches for Refugees in its early days, his guidance as chairman that saw it become a charitable body, and for taking on the role of Lead Sponsor within the resettlement scheme.

1. The meeting received the Annual Statement of accounts for the year ended 31st December 2019 (Proposed: D. Fidler Seconded: M. Sherman)
2. The meeting received the Trustee's Annual Report (Proposed: D. Fidler Seconded: J Troughton)
3. The following had been nominated as trustees by Churches Together in Louth and District, and were confirmed as trustees:

Derek Gibson
4. One nomination was received for an elected trustee, and therefore David Fidler was declared elected (two vacancies remaining unfilled)

The formal business of the meeting was concluded, and followed by informal discussion on the work of the charity and the situation it was seeking to relieve, including:

- The issue of time-limited donations, and thanking people for their much valued support for the work of the charity;
- The wider work of supporting refugees (which had taken a less prominent place in activities since the resettlement had taken place); and
- Whether the charity would look to support another family, should this become a possibility.

The charity's main activities during the year have included: <ul style="list-style-type: none">Preparations towards welcoming a resettled family in Louth.Welcoming the family and providing ongoing support during the year, making adjustments to arrangements as necessary during pandemic restrictions.Reviewing and relaunching charity communications to raise awareness of the activities of the charity and the global situation facing refugees; and encouraging prayer.Beginning considerations around future planning for the charity.
Statement confirming whether the trustees have had regard to the guidance issued by the Charity Commission on public benefit.	In all of the charity's work, the trustees have been mindful of the need to fulfil the charity's charitable purposes and to work for the public benefit. They believe that this has been the case, and that the activities represented by the summary above and in the report that follows demonstrate both the ways in which Louth Churches for Refugees has fulfilled its purposes of relieving financial hardship of those groups specified in its governing document and that this has been undertaken in a way that is demonstrably for the public benefit.

Achievements and Performance

<p>Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.</p>	<p>It is now a year since we welcomed the family to join our community here in Louth. Amid all the challenges of 2020, they have worked hard to settle down to life here. It has not been easy - the family have had to deal with a new language, a different climate, a different culture — and all this within the extra problems caused by Covid19.</p> <p>As a charity our support for the family during the past year has been wide-ranging, including help with issues like housing, language learning, and education more generally. We have also provided considerable support in navigating practicalities like bureaucracy.</p> <p>The settling-in process is challenging: to settle into a new community one needs to discover what is going on, and there is a need for locals to invite in-comers to join in. This has been made more difficult during 2020 because most community events have been closed down. In the future we need to find out more of what the family can offer to our community and what the community can offer to this new family.</p> <p>We have reviewed our approach to communications during the year: our website has been updated and we have begun a planned programme of social media activity covering the work of the charity; global issues concerning refugees; and on the theme of prayer/spirituality. Trustees have also been involved in campaigning related to our charitable objectives, including correspondence with our MP on a range of issues during 2020.</p> <p>At the 2020 AGM John Troughton retired as trustee and we want to express our sincere thanks to John for his huge contribution to the work of the charity from the start, and in his role as Chair of the Trustees. Thanks from the Trustees also go to Canon Nick Brown who has provided valuable support to the charity over the years and we send Nick our warm wishes for the next phase of his ministry in Lincoln.</p> <p>Looking into the future, the Trustees have begun a process of future planning, considering options for the ways in which the work of the charity might continue to develop. We will hold an open meeting for all who may be interested in supporting us as soon as this is permitted by the pandemic restrictions.</p> <p>Louth Churches for Refugees is still a small group.
